- 1) Rigged up workover rig December 29, 1971.
- 2) Cleaned out with bit 3705-3725'. Pulled bridge plug at 3725'.
- 3) Cleaned out with bit from 3798-3878' (total depth).
- 4) Ran 2-3/8" OD tubing and set at 3803' with pump at 3772'. Ran rods. Tested.
- 5) Returned well to production status on January 11, 1972, producing 37 bbls. oil and 60 bbls. water per day through 5-1/2" OD casing perforations 3269-3710' and open-hole section 3758-3878' of the Grayburg-San Andres formation.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
