Moved in and rigged up pulling unit. Pulled rods and tubing. Reran 101 Jts. (3072') of 2-3/8" OD tubing with Baker AD-1 Tension Packer set at 3000'. Installed water injection equipment. Water will be injected through 3-1/2" OD casing into perforations 3162-3782' of the Grayburg and San Andres Formations.

This will be a water injection well for the Shelly Unit, operated by Shelly Oil Company.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
