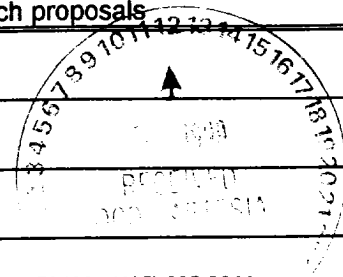

3. RIH with Baker Lock-Set packer on 2 3/8" tubing and set at $\pm 2700'$.
4. Inject through perforations 2750'- 3550'(OA).
