5/12/97 - Cleaned out to 3330'. Set CIBP @ 3270'. Perf'd @ 2679'-3179' w/26 holes.
5/13/97 - Acidized perms 2879'-3179' w/3000 gals 15% HCl acid + 4500# rock salt.
5/15/97 to 5/17/97 - Found hole in 8 5/8" casing. Cut off 8 5/8" @ 27' from surface and welded new 27' piece of 8 5/8" casing.
5/21/97 - Dumped 10 sxs cement down 4 1/2" x 8 5/8" annulus. TOC @ 4' from surface.
5/22/97 - Ran AD-1 packer & 2 3/8" IPC tubing. Set pkr @ 2617'. Ran chart.
5/24/97 - Back on injection.
