Instructions

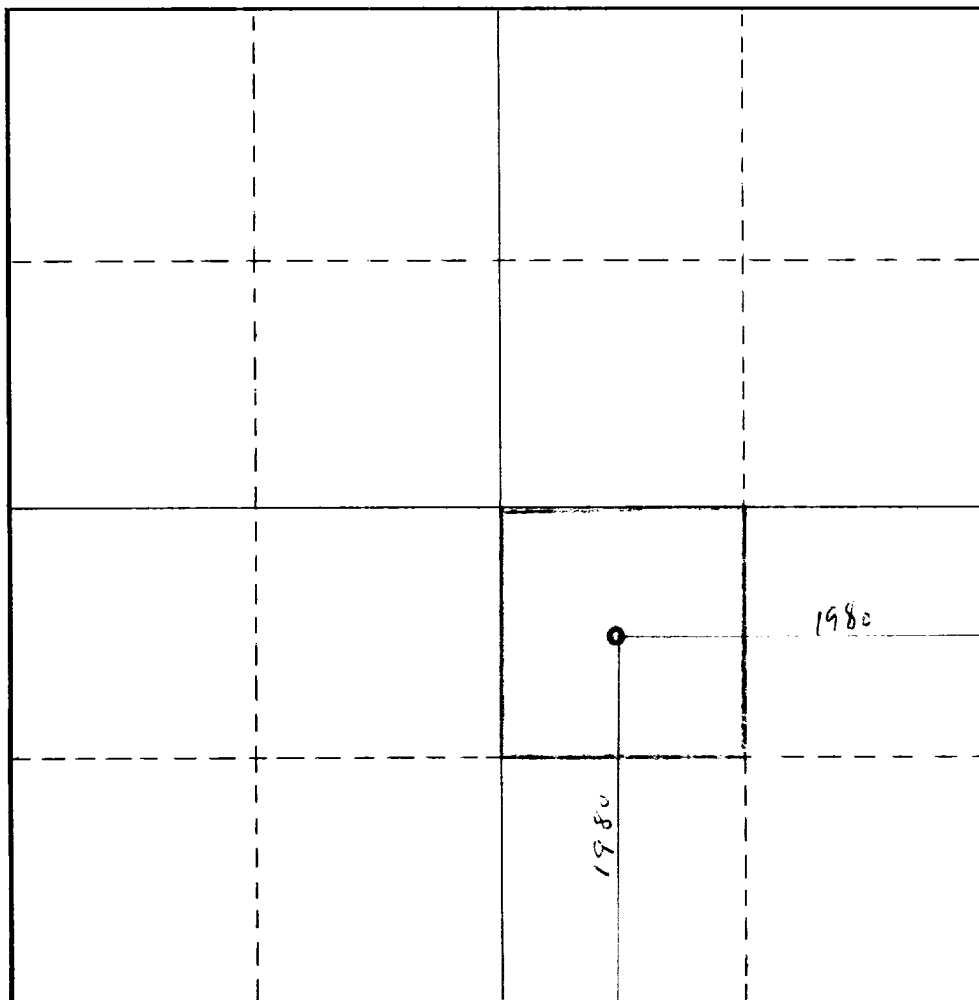
