1. Well spudded at 4:00 P. M. 1-21-72.
2. Ran 479' KB 8-5/8" 20# casing as follows:
 - a. Run Volume of cement equalled 132 cubic feet (100 sacks).
 - b. Brand of cement was Southwestern Class C with 2% CaCl.
 - c. Approximate temperature of cement slurry 60°.
 - d. Formation temperature 90°.
 - e. After standing cemented for 9 hours compressive strength was 800#. Pressure tested to 4,000#. Tested OK.
 - f. Drilled out cement after standing 12 hours.
3. Ran 3700' KB of 4-1/2" 9.5# casing and cemented with 425 sacks cement.
4. We perforated as follows: 2482'-2490', 2579'-2589', 2612'-2616', 2657'-2663', 3035'-3039', 3086'-3090', 3121'-3125', 3133'-3139', 3289'-3305', 3542'-3549'.
5. We fraced and acidized as follows: 2482'-2490', frac with 30,000# sand and 30,000 gallons water; 2579'-2616', frac with 30,000# sand and 30,000 gallons water; 2657'-2673', acidized with 3500 gallons acid; 3035'-3139', acidized with 4000 gallons acid; 3289'-3305', frac with 30,000# sand and 30,000 gallons water; 3542'-3549', frac with 30,000# sand and 30,000 gallons water.

CONDITIONS OF APPROVAL, IF ANY:

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations; and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
