Cemented csg as follows: 750 sx PSL "C" + 4% Ataclay + 10% Salt + 1/4 #/sk Celloseal. (Weight 12.7 #/gal, yield 1.95 cf/sk.) Tail in w/ 325 sx H + 10% thixad/sk + 1/4 #/sk Celloseal. (Weight 14.5 #/gal, yield 1.52 cf/sk.)

Circulated 140 sx cmt to surface.
