We propose to plug and abandon the Sivley Denton Federal #1 as follows:

1. Pull Kobe pump & equipment, run tubing.
2. Set 20 sack cement plug @ 8550' - 8640'.
3. Cut & retrieve 4 1/2" casing @ approximately 7,000' or lowest free point.
4. Set 25 sack cement plug half in and out of 4 1/2" casing stub.
5. Set 35 sack cement plug @ 4700-4800'.
6. Set 35 sack cement plug @ 2825-2925'.
7. Set 35 sack cement plug @ 1950-2050'.
8. Set 35 sack cement plug @ 900-1000'.
9. Set 10 sack cement plug @ surface.
10. Erect regulation marker.

We propose to fill all void spaces between cement plugs with good mud.

### Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable local, area, or regional procedures and practices, either as shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices. In addition, such proposals and reports should include reasons for the abandonment; data on any former or present productive zones, or other zones with present significant fluid contents not sealed off by cement or otherwise; depths (top and bottom) and method of placement of cement plugs; mud or other material placed below, between and above plugs; amount, size, method of parting of any casing, liner or tubing pulled and the depth to top of any left in the hole; method of closing top of well; and date well site conditioned for final inspection looking to approval of the abandonment.
