DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was drilled to total depth of 2150' in lime and plugged back to 2000' without encountering oil or gas. Commercial quantities of gas were encountered. Plugging was done in the following manner: Plugged back with cement to 1800'. Hole was filled with 12# cement from 2000' to 1800'. After salvaging 1500' of casing, a 2 1/2" plug was placed from 1800' to 1830'. Hole was filled with 12# cement from surface. Cemented to surface. A marker was erected and location restored to its original condition.
