WE FEEL THAT WE HAVE MERITED YOUR CONTINUED TRUST AND CONFIDENCE IN THE PAST AND ARE JUSTIFIED IN ASKING FOR YOUR CONSIDERATION IN CONNECTION WITH THIS PARTICULAR MATTER.
