

DETAILS OF WORK

On June 28th a 25 sack cement plug was placed from 150 to 350 (top salt 400') thru 2 5/8" drill pipe. Hole was temporarily abandoned on June 6, 1962 with hole full of heavy mud. Then drill pipe was raised to 75' where a 10 sack cement plug was placed below 8 5/8" cemented at 65'. Marker was erected, pits filled and ground cleaned for final inspection.
