Detailed description of Figure 1: The graph plots 'Percentage of total catch' on the y-axis (0-100) against 'Percentage of total effort' on the x-axis (0-100). Several data series are shown for different fish species. Yellow perch starts at approximately 80% catch for 10% effort and drops sharply to near 0% catch for 40% effort. Rock bass and White perch show more gradual declines. Striped bass and other species show lower catch percentages across the range of effort.

1. *Chlorophyll a* and *Chlorophyll b* were determined by the method of Arar and Collins (1971) using a Shimadzu 1010 spectrophotometer. The concentration of chlorophyll was expressed as  $\mu\text{g mL}^{-1}$  of the sample.
