DETAILS OF WORK

Cement 150 ft of 7 inch casing with 15 sacks to shut off surface waters. Drill 6 1/2 inch hole to top of the Russell sand at approx. 800 ft. Run 1/2 inch casing 3 T.D. cemented with 60 sacks (calculated enough to fill 150% through salt section). Fill drill sand and then decide on producing or injecting water.

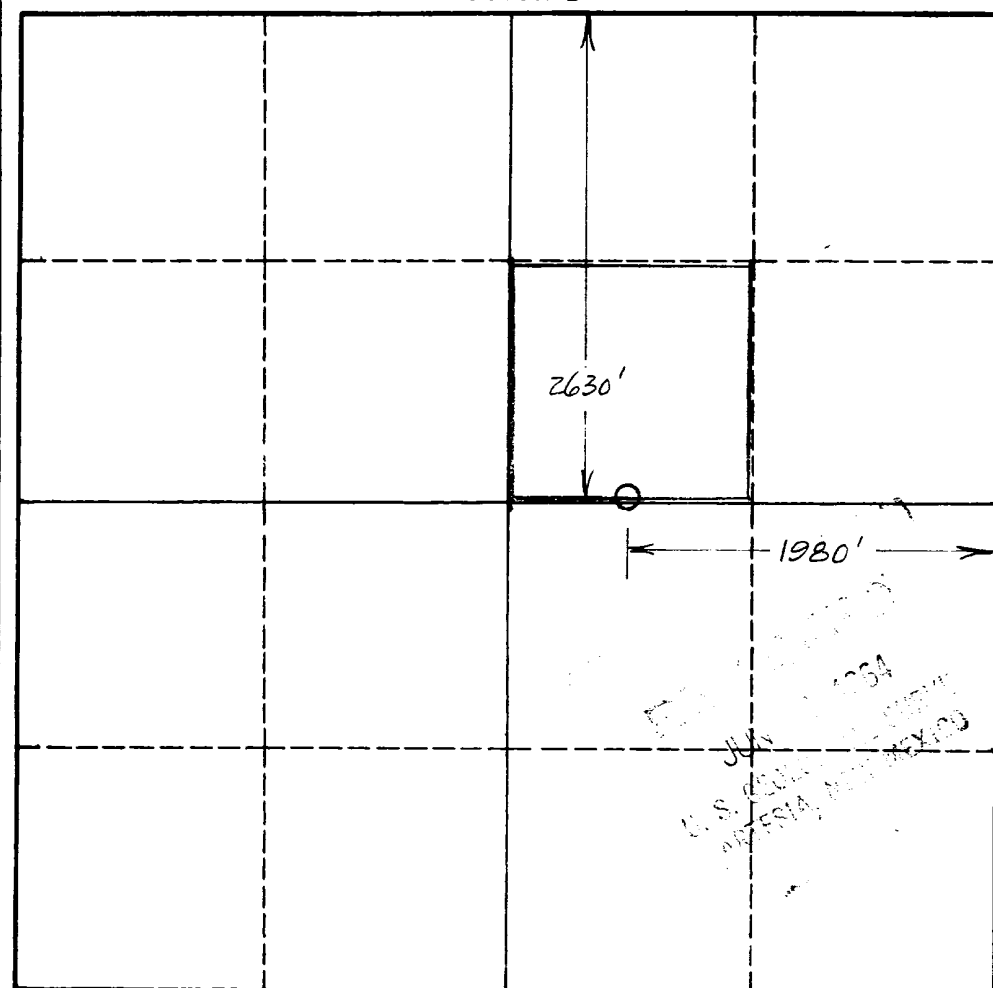

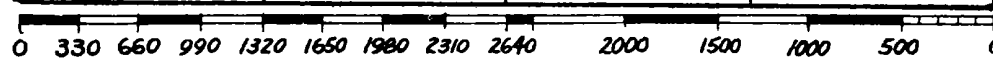
