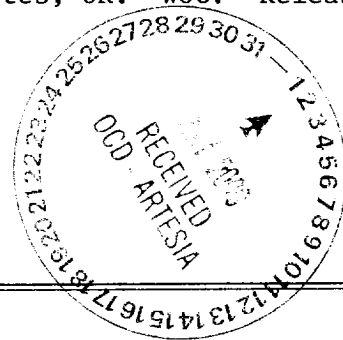
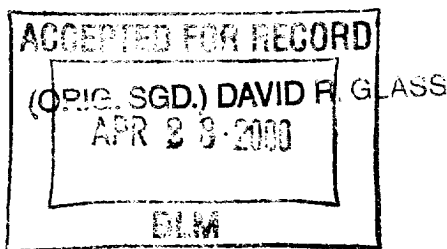

TD 10484'. Reached TD at 2:00 PM 3-16-2000. Ran 254 joints of 7" 26# M-95/P-110 (10513.06') of casing set at 10480'. Float shoe set at 10480'. Float collar set at 10437'. Bottom marker set from 9847-9826'. Top marker set from 7792-7773'. Cemented with 775 sacks "C" (65-35-6), 6% gel, 5#/sack gilsonite and .2% LWL (yield 1.99, weight 12.4). Tailed in with 675 sacks "C" (61-15-11), .7% FL52, .7% FL25 and 5#/sack gilsonite (yield 1.56, weight 13.2). PD 2:30 AM 3-18-2000. Bumped plug to 2500 psi for 15 minutes, OK. WOC. Released rig at 7:00 AM 3-19-2000.
