Set CIBP at 11,710' with two sacks of cement on top of plug; came up hole to Atoka zone and perforated zones 11,672-66'; 11,658-56'; 11,632-28'; 11,622-18'; 11,614-10'; 11,570-64'; 11,516-08'; and 11,442-36', acidized with 10,000 gallons 15% acid and swabbed test zones.

Came up hole, set R.B.P. at 11,350', perforated zones 11,266-54'; 11,242-36'; 11,228-24'; and 11,221-19', acidized these zones with 5,000 gallons 15% acid and swabbed test zones.

All zones were perforated with 2 shots per foot.

Production tested and put on line 8/17/94.

Production Test 8/15/94: Flowing - 24 hours, 11/64" choke, TP 2000#, CP 0#, 1,002 MCF, 0 BO, 0 BW.
