08/21/90: Found fluid level @ 800'. Swabbed 12 hrs., recovered 247 bbls. wtr.. Last 2 swab runs, had slight show of gas, no oil & no sand. Last run, fluid level @ 2,000'. 228 bbls. under load.

08/22/90: Fluid level @ 1,200'. Swabbed 10 hrs. & recovered 184 BW, last 6 swab runs had trace of oil, slight show of gas & no sand. 44 bbls. under load.

08/23/90: Fluid level @ 1,300'. Swabbed 12 hrs. & recovered 191 BW & 1 BO, very little to no gas & no sand. Last swab run, fluid level @ 2,200'. 148 bbls. over load.

08/24/90: Fluid level @ 1,500'. Swabbed 9½ hrs. & recovered 141 BW and no oil. Last swab run, fluid level @ 2,100'. 289 bbls. over load.

Contacted Mr. Adam Salameh with the BLM for plugging procedure. Procedure is as follows:

- 1) Set CIBP @ 3,146'
- 2) Circ. hole w/10# brine gel wtr.
- 3) Cap CIBP @ 3,146' w/50' plug (3 Sks. Premium Plus Neat Cmt.)
- 4) Spot 6 Sks. Premium Plus Cmt. + 3% calcium chloride at 2,016'. WOC 3 hrs.. Tag plug w/2,000# wt.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
