8/28/92 Rigged up and perforated additional Lower Delaware zone from 8058' - 8096' (1 sp2f, 20 holes).

8/29/92 Pumped 2,600 gals HCl acid + 40 ball sealers to breakdown the perfs. Swabbed back and prepared to frac.

9/2/92 Frac'd with 24,000 gals gelled 2% KCl water + 30,500 lbs 20/40 mesh Ottawa sand. Shut down overnight. Began swabbing back fluid the next day.

9/5/92 Ran rods. Put the well on pump.

9/16/92- Rigged up pulling unit again. Killed the well. Attempted to clean-out sand
9/22/92 fill. Put back on pump.

The well is currently making 66 bopd, 84 mcfd, 62 bwpd.
