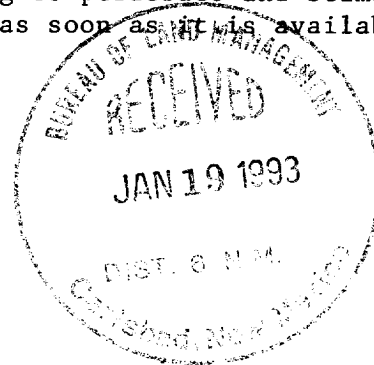

On 1/9/93, we perforated this new well in the Delaware formation from 8150' - 8202' with 104 holes. The perms were acidized with 2200 gals of 15% NEFE HCl acid + 125 ball sealers. On 1/12/93, we fracture stimulated these perms with 46,000 gals gelled 2% KCl water and 42,500 lbs of 20/40 mesh sand. The well was opened immediately following the frac for forced closure flowback. Currently, we are preparing to perforate and stimulate a second set of Delaware perms. Test data will be submitted as soon as it is available.
