We completed the Delaware formation as follows:

12/13/92 The Delaware formation was perforated from 8102' - 8164' (62 holes)

12/15/92 The perfs were acidized with 2000 gals 15% NEFE HCl acid + 80 ball sealers

12/17/92 The formation was fracture stimulated with 39,700 gals gelled 2% KCl water and 38,000 lbs 20/40 sand. The well was opened to the pit for forced closure flowback immediately following the frac.

Currently, we are recovering the load and testing. Test results will be reported as soon as possible.
