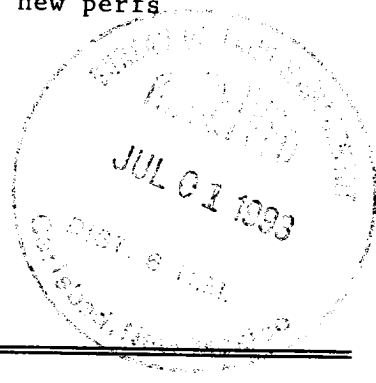

24,500 lbs 16/30 sand + 10,000 lbs 16/30 resin coated sand. The well
was flowed back immediately following the frac for forced closure.

Currently, we are recovering the load and pump testing the well. The new perfs
will be commingled with the existing Lower Brushy Canyon perfs.
