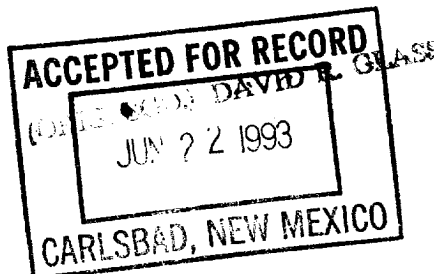

13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. On 5-14-93 and 5-15-93, we selectively perforated the Lower Brushy Canyon 'A', 'B', 'C' and 'D' zones from 8047' - 8164' with 22 holes. The holes were acidized with 1500 gals 7 1/2% NEFE acid + 50 ball sealers. The following day, we fraced the perfs with 49,900 gals gelled 2% KCl water + 117,000 lbs 20/40 sand and 40,000 lbs 16/30 resin coated sand. The well was flowed back immediately for forced closure. Following flowback, we cleaned out the sand, swabbed 245 bbls of load and ran pump and rods. The well was on pump 5/27/93. Currently, we are pumping back the load and testing. A test will be submitted as soon as it is available.
