**13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. We spud this new well at 1700 hours on 10/5/93. On 10/6/93, we ran 859' of 13 3/8" surface casing in a 17 1/2" open hole. The casing was cemented to surface with the following cement slurries:

500 sx LITE (35:65) + 6% gel + 2% CaCl<sub>2</sub> + 1/4 lb/sk cellophane flakes  
(slurry weight = 12.7 ppg, slurry yield = 1.88 cft/sk)

200 sx CLASS "C" + 2% CaCl<sub>2</sub> + 1/4 lb/sk cellophane flakes  
(slurry weight = 14.8 ppg, slurry yield = 1.32 cft/sk)

We circulated 113 sx of cement to surface. WOC time = 24 hours.
