13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent data, including estimated date of starting any proposed work. On 7-12-93, we perforated the Lower Brushy Canyon from 8184'-8214' and 8088'-8104' (1 sp2f, 4" casing gun, 25 holes). The perfs were acidized on 7-14-93 with 1500 gals 7 1/2% NEFEE acid + 30 ball sealers. The next day, the perfs were fraced with 67,578 gals crosslinked 2% KCl water + 142,500 lbs 16/30 Ottawa sand and 60,000 lbs 16/30 resin coated sand at 30 bpm via 5 1/2" casing. The well was opened for forced closure immediately following the frac. We recovered 15 bbls and then shut the well in overnight. Currently, we are testing the well.
