7/14/93: Logging. RU casing crew. Ran 182 jts 5-1/2" 15.5 & 17# K-55 LT&C casing and set at 8070'. Stage tool at 5975'. Cemented w/ 500 sx Cl "H" + .8/10% FL25 and 5 pps KCl. Cemented 2nd stage w/ 125 sx "C" Lite 35:65:6. Tail w/400 sx "C" Neat. (Note: Circ'd 70 sx cmt to pit on 1st stage).

7/15/93: ND, set slips w/ 10,500#. Cut off 5-1/2". Install tbg head and test to 3000 psi. Jet and clean pits. Released rig at 10:30 a.m. CST. WOCU.
