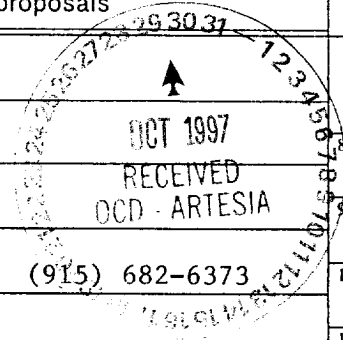

Santa Fe Energy respectfully requests the casing design of the 8 5/8" intermediate be changed from 3000' of 8 5/8" 32.0 ppf K-55 casing, to 800' of 8 5/8" 32.0 ppf J-55 casing followed by 2200' of 8 5/8" 24.0 ppf J-55 Casing. Cement will remain the same with approximately 850 sx to circulate to surface.
