- 1) Killed well w/brine water.
- 2) Set plug in nipple profile @ 6627'
- 3) Set RBP in 7" casing @ 6516'.
- 4) Set packer @ 3400', test to 350 psi below packer, held O.K. Pump into annulus @ 1.5 BPM. Could not set packer between 3400' & surface.
- 5) Run cement bond log - TOC @ 5830'. CBL indicated cement @ 500'-750'.
- 6) Ran casing inspection log (Atlas Wireline's Vertilog) from 6081' to surface. Log indicated possible holes over entire length of 7" casing.
- 7) Ran 4-1/2" casing (Inspected 4-1/2" tubing that was in the well as tubing to use as liner) w/HOWCO FO cementing tool @ 6566'.
- 8) Hydrostatic test 4-1/2" to 3000 psi.
- 9) Latch 4-1/2" into Baker Model FA-1 packer @ 6600'.
- 10) Run in hole w/2-7/8" tubing, open FO cementing tool @ 6566'
- 11) Cement 4-1/2" casing w/1470 sx premium lite, tailed in w/200 sx premium neat. (Volume calculated on a 4-1/2"-8-3/4" open hole annulus plus 50%)

- 12) Circulated cement out both the 4-1/2" & 7" when 1100 sx mixed. Partially closed valve on return line exerting 400 psi back pressure on formation. Squeezed estimated 285 sx outside 7" casing.
- 13) Close FO tool & POH w/tubing.
- 14) Could not retrieve plug from nipple profile @ 6627'. Cut 10', 4-1/2" sub @ 6606' & drop plug & nipple to bottom.
- 15) Run in hole w/wireline & set Model "R" Baker packer @ 6550' w/plug in profile.
- 16) RIH w/2-7/8" tubing & latch into packer.
- 17) Could not retrieve plug from profile. Perforated w/12 shots from 6555'-6558'.
- 18) Return well to injection status.
