Aleeca,

After reviewing the GW-100 case file the OCD determination is that approval from Mr. Glen Von Gonten indeed approved closure for any soil/ground water impacts related to the discharge permit. In regard to the monitor wells still onsite, the operator may proceed with plugging per New Mexico Office of State Engineer closure requirements.

Please keep in mind that approval of closure by the OCD does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that pose a threat to groundwater, surface water, human health or the environment. In addition, OCD acceptance of closure does not relieve the operator of responsibility for compliance with any other federal, state, or local laws and/or regulations.

Hi Cory,

There have not been any groundwater samples collected since 1997. Since COC concentrations were less than the applicable standards in both 1996 and 1997, DSI requested approval to terminate the groundwater sampling program from NMOCD. The NMOCD approved termination of groundwater sampling but requested the retention of the monitoring wells (as opposed to plugging and abandoning the wells).

I have attached the NMOCD approval to terminate groundwater sampling so you don't have to comb through more files.
