

10/23/02 Perforate Pictured Cliffs 4250'-4464'. Acidized with 1000 gals. 15% HCL. Frac PC with 42,684 gals. 70Q foam & 180,000# 20/40 sand.
10/24-27/02 Flow back after frac.
10/28/02 TIH. Clean out to 4800'. Retrive RBP. TOH.
10/30/02 TIH with 2-3/8" tubing, land @ 6830'. Return to production.
