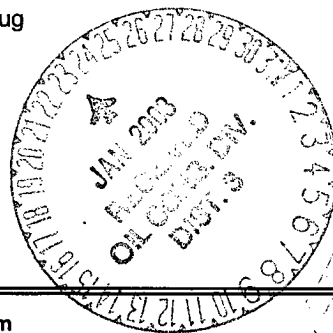

Displaced w/14 bbls FW. Bumped plug w/350 psi. Circ. 10 bbls cement to surface. WOC. NU WH & BOP. PT casing to 500 psi for 30 minutes. Good test.
