All terms of the original APD remain the same. Richardson has finally received the necessary Tribal and BIA approvals.

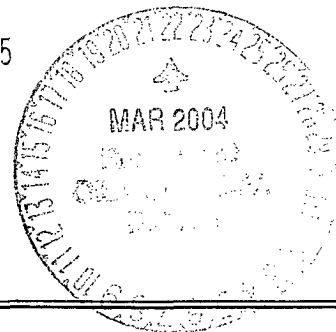
