Tail-100 sx (133 cf - 23.68 bbl slurry) 50/50/STD/POZ cement w/2% gel, 2% CaCl<sub>2</sub>, 5#/sx Gilsonite & 1/4#/sx Flocele. Released wiper plug & displaced w/132 bbls FW. Bumped plug w/1500 psi. Circ. 15 bbls good cement to surface. RD Halliburton. Changed rams. ND & PU BOP Stack. Set slips and cut off casing. Installed trash cap. RD & released rig 1000 hrs 2/24/03.
