Pumped a preflush of 5 bbls dye water ahead of 150 sx (201 cf) 50/50 STD/POZ, 2% Bentonite, 5#/sx Gilsonite, 3% CaCl2, 25#/sx Cello-flake, 0.2% CFR-3. Dropped plug and displaced w/15 bbls water. Avg rate - 3 bpm, 69 psi lift pressure. Bumped plug w/150 psi. Circ. 15 bbls good cement to surface. WOC. NU WH & BOP. PT-OK. PT pipe & blind rams, lines & manifold - OK. PT casing to 1000 psi for 30 minutes w/rig pump. Good test.
