Cmted w/412 sxs Premium Lite cmt w/0.25 pps celloflake, 5 pps LCM-1, 0.4% SMS, 8% bentonite, 3% calcium chloride, 0.4% fluid loss (878 cu. ft.). Tail w/90 sxs Type III cmt. w/1% calcium chloride, .25 pps celloflake, 0.2% fluid loss (124 cu. ft.). Circ 89 bbls cmt to surface. WOC.

2/17/04 PT BOP & csg to 1500 psi/30 mins, OK. Drilling ahead.
