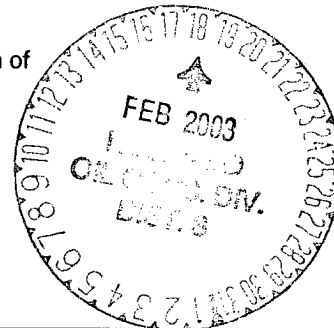

Tail - 100 sx (126.7 cf - 22.56 bbl slurry) 50/50 STD POZ cement w/2% gel, 2% CaCl2, 5#/sx Gilsonite & 1/4#/sx Flocele. Released wiper plug & displaced w/118 bbl FW. Bumped plug w/1780 psi. Circulated 6 bbls cement to surface. RD Halliburton. ND BOPs, set slips and cut off casing. Installed well cap. RD & released rig 0800 hrs 1/28/03. Will show 7" casing PT on next report.
