Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped Lead - 415 sx (1083 cf - 192.9 bbl slurry) Class G cement w/3% Chemical extender, 0.25#/sx Cellophane flake, 0.05 g/sx Antifoam agent & 0.2% all purpose Antifoam agent. Tail - pumped 100 sx (127 cf - 22.6 bbl slurry) 50/50/G/POZ cement w/2% Bentonite, 2% CaCl₂, 5#/sx Gilsonite, 0.25#/sx Cellophane flake & 0.1% all purpose antifoam agent. Released wiper plug and displaced w/20 bbls FW & 105.7 bbls slightly polymerized drill water. Bumped plug w/1450 psi @ 0846 hrs 3/24/04. Circ. 40 bbls cement to surface. RD Schlumberger. Changed rams to 4-1/2", ND BOP, set slips and cut off casing. Installed trash cap. RD & released rig @ 1600 hrs 3/24/04. Will show 7" casing PT on next report.
