Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped Lead - 415 sx (1083.2 cf - 192.9 bbl slurry) Class G cement w/3% Chemical extender, 0.25#/sx Cellophane flake, 0.05 g/sx Antifoam & 0.2% all purpose antifoam agent. Tail - pumped 100 sx (127 cf - 22.6 bbl slurry) 50/50/G/POZ cement w/2% Bentonite, 2% CaCl<sub>2</sub>, 5#/sx Gilsonite, 0.25#/sx Cellophane flake, & 0.1% antifoam agent. Released wiper plug and displaced w/20 bbls FW & 107.3 bbls slight polymerized drilled water. Bumped plug w/1470 psi @ 1640 hrs 3/28/04. Circ. 37 bbls good cement to surface. RD Schlumberger. Changed out 7" rams to 4-1/2". ND BOP, set slips and cut off casing. Installed trash cap. RD & released rig @ 2400 hrs 3/28/04. Will show casing PT on next report.
