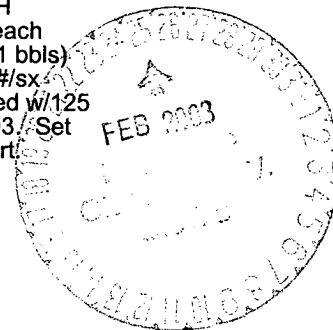

Pumped a spacer of 5 bbls each KCL/Gel/KCL water. Pumped a scavenger cement of 25 sx (10 bbls) then 1st Lead - 50 sx (21 bbls) w/4#/sx Phenoseal, 2nd Lead - 230 sx (82 bbls w/2.5#/sx phenoseal. Tail - 25 sx (8 bbls) w/4#/sx pheno-seal. All cement is PLHS FM w/2% CD-32, .75% FL-32, 3#/sx CSSE, .25#/sx. Displaced w/125 bbls 2% KCl. Bumped plug w/1500 psi. Released & re-bumped. Plug down @ 1035 hrs 2/7/03. Set slips and cut off casing. RD & released rig 1700 hrs 2/7/03. Will show casing PT on next report.
