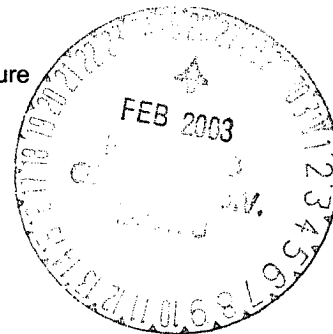

It is our intent to try a different artificial lift such as casing plunger. If these attempts fail to bring the well back to production we will request to recomple into the PC.
