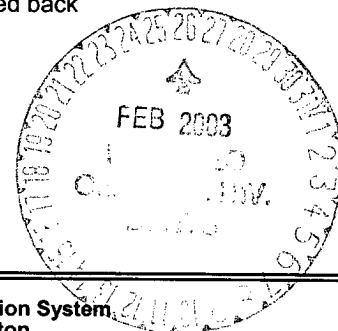

Richardson Operating Co. plans to plug back each of this well to the Pictured Cliffs formation following the procedure submitted in the sundry dated July 6, 2000. However, Richardson Operating Co. has not received approval for pipelines for these wells. Therefore, they will be temporarily abandoned until the gas can be transported from location. The wells are planned to be plugged back in the Spring of 2003 and completed in late 2003.
