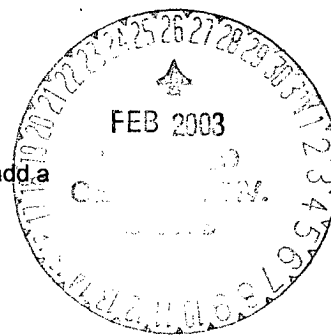

In June 02 liquid loading and increasing line pressure shut-in the well.

In order to fully evaluate production potential in the Pictured Cliffs reservoir we intend to add a pumping unit and possibly wellhead compression at a later date.
