Elm Ridge Resources, Inc intends to plug the well in accordance with regulations. Production equipment will be removed and well will be plugged as specified. Perforate and squeeze will be used. Notify the Farmington BLM office at 505-599-8907 24 hours prior to commencement of plugging operations. Pull all retrievable downhole production equipment. Set a CIBP @ 4550'. Spot cement to 4350'. Set a 100' cement plug from 3800' to 3700' across Mancos top @ 3765'. Set a 100' cement plug from 1970' to 1870' across Mesa Verde top @ 1920' inside & outside 4-1/2" casing. Set a 100' cement plug from 1230' to 1130' across Pictured Cliffs top @ 1180' inside and outside of 4-1/2" casing. Set a 100' cement plug from 808' to 798' across Fruitland Coal top @ 848' inside and outside of 4-1/2" casing. Set a cement plug from surface to 350' across the surface casing shoe @ 212' inside and outside of 4-1/2" casing. Cut wellhead and install dry hole marker. Clear and remediate location.
