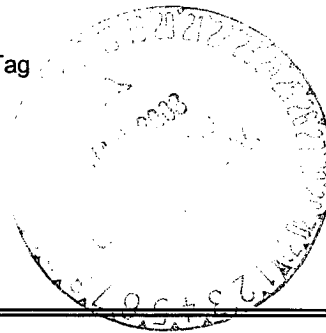

Spot sand in bottom of well to cover PC perforations. Tag sand at 1044'. Spot 14 cu ft Class "B" cement with 3% CaCl₂ at 1044'. Tag cement at 560'. Perforate 2-7/8" production casing at 196'. Pump 35 cu ft Class "B" cement down casing and return to surface. Job complete on 12/20/02. Tag cement at 100' inside casing with cement outside casing at 2'. Filled casing with cement. Set dry hole marker.
