Check anchors. MIRU workover rig.
Check and record tubing, casing, and bradenhead pressures.
Blow down wellhead. Kill with 2% KCL water ONLY if necessary.
NDWH. NU BOPs. Pressure test to 500 psi.
POH with 2-3/8" production tubing currently set at 7315'.
RIH with work string and clean out hole to top of packer at 7315'. POH.
RIH with CIBP and set at 7300'.
RIH with 2-3/8" production tubing. Land tubing at 5300'.
ND BOPs. NUWH. Test well for air. Return well to production.
