3. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. This well produces 43 Bbl/Day of water from the Basal Fruitland Coal.

The produced water is either transported by pipeline to a Richardson Operating Company disposal well or stored on location in an above ground water tank. If the water is stored on location, Richardson Operating Co. trucks the water to the disposal well unless workload dictates that a third-party trucking company is needed to keep up with water. When water production exceeds the capacity of the two Richardson injection wells, water is disposed of by Key Energy Services in their disposal facility.

Richardson Operating Company operates two active salt water disposal wells in the area: Salty Dog #1 (WDW-NW/NE Sec. 1, T29N, R15W) and Salty Dog #2 (WDW-NW/SE Sec. 5, T29N, R14W).

Copies of the NMOCD Injection Order for each injection well should be on file with the BLM.
