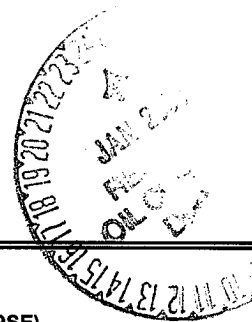

PU & landed tubing @ 5617' w/"F" nipple set @ 5610'. ND BOP, NU WH. Pumped off expendable check. RD & release rig 12/20/02. Turned back over to production to put back on line.
