12/08/02 Plug back after frac.

12/09-10/02 TIH. Clean out to RBP, retrieve RBP. TOH.

12/11/02 TIH. Clean out to 6200'. TOH. TIH with 2-3/8" tubing, land @ 5938'. NU wellhead. Return to production.
