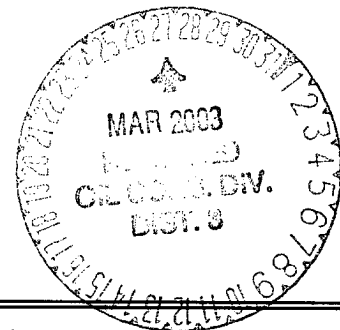

It is intended to restimulate the Pictured Cliffs formation in the subject well as follows:

Move in, rig up. Pull tubing. Deepen the well to approximately 2298'. Run 4 1/2" 10.5# J-55 ST&C csg. to total depth. Cement 4 1/2" casing with 150 sacks lead cement (yield of 2.13 cu.ft per sack, 12.10 ppg). Tail with 50 sacks cement (yield of 1.47 cu.ft per sack, 14.20 ppg). Fracture stimulate the Pictured Cliffs formation. Run production tubing. Return well to production.
