Drill 12-1/4" hole to 280'. On 2/12/02 ran 6 jts. 9 5/8" ST&C 32.3#, H-40 casing. Set at 273'. Cement with 150 sacks (33 bbls) Class B cement, 2% CaCl, 1/4# PSX Flosele, yield 1.18. Circulate 12 bbls cement to surface. Pressure test casing to 1500 psi.

Drill 8-3/4" hole to 3654'. On 2/16/03 ran 7", 23#, J-55 LT&C casing. Set at 3634'. Cement with Lead: 450 sacks (116 bbls) Class "B" 50/50 POZ, 2% gel, .2% versaset, .1% Diacel LWL foamed, yield 1.45. Tail in w/75 sacks Class B 2% gel, .2% Versaset & .1% Diacel LWL non-foamed, yield 1.45. Circlate 24 bbls cement to surface. Pressures test casing to 1500 psi.

Drill 6-1/4" hole to 8080'. On 2/19/03 ran 1 jt. 4.5" 11.6# J-55 LT&C casing. Set at 8075'. Cement with 525 sacks (137 bbls) w/3% gel, 1.4% Halad 9, .1% CFR5, .1% HR5, 5# gilsonite & 1/4# flocele, yield 1.47. Top of Cement: 7800'. Pressure test casing to 4500 psi.
