Drilled 12-1/4" hole to 302'. On 1/29/2004 set 6 jts 9-5/8" 32.3# casing at 296'. Cemented with 175 sx (37 bbls) "B" cement w/ 2% CaCl2 and 1/4# Flocele. Circulate 17 bbls cement to surface. Test casing to 1500 psi.

Drilled 8-3/4" hole to 4109'. On 2/12/2004 set 93 bjts 7" 23# casing at 4095'. Cemented w/ 660 sx (172 bbls) 50/50 Poz w/ 3% gel, 0.4% Halad 344, 0.1% CFR-3, 5# Gilsonite, and 1/4# Flocele. Tailed in with 75 sx (13 bbls) class "B" w/ 0.4% Halad 344. Circulate 12 bbls cement to surface. Test casing to 1500 psi.

Drilled 6-1/4" hole to 4434'. Underreamed hole to 9-1/2" from 4095' to 4434'. Utilized natural and air assisted surges to remove near wellbore material. No casing was run or cement pumped in this section of hole. If hole conditions dictate, at a later date we may run a 5-1/2" liner in hole. Production tubing (2-3/8") was set in well at 4313'.
