3/18/04 RIH w/8-3/4" bit & tagged cement @ 180'. Drilled cement & then formation to 3917'. Circ. hole. RIH w/7", 20#, J-55 ST&C casing and set @ 3917'. RU Halliburton to cement. Pumped a preflush of 20 bbls water w/dye in last 10. Pumped Lead - 400 sx (1152 cf) STD, 3% Econolite, 10#/sx Pheno-seal. Tail - pumped 230 sx (306 cf) 50/50 STD POZ, 2% Bentonite, 6#/sx Pheno-seal. Dropped plug and displaced w/156 bbls water. Bumped plug to 2150 psi. Plug down @ 2000 hrs 3/21/04. Circ. 90 bbls good cement to surface. Wash out BOP. ND BOP, set slips and cut off casing. PT BOP-OK. WOC. PT casing to 1800 psi for 30 mintues. Good test.
